CONSENT ORDER TO SEAL CONFIDENTIAL RECORD

UPON CONSIDERATION of the parties' agreement to Seal Confidential Record, the Court, having reviewed the file and being otherwise fully advised in the premises does hereby

FIND AS FOLLOWS:

A. A Final Judgment was entered herein on October 12, 2018. An Amended Final Judgment was entered herein on October 30, 2018. There is one minor child of the parties, age 13.

B. The final judgment and amended final judgment contain highly sensitive and personal information about the parent(s). It would be detrimental to the minor child of the parties if said final judgments were available to the public and thus potentially available to the child and not made confidential. Disclosure of this information would cause substantial injury to the parties, and their children, and is, therefore, confidential under Rule 2.420(c)(9) of the Florida Rules of Judicial Administration.

B. The degree, duration, and manner of the requested confidentiality of the

final judgments are no broader than necessary to protect the interests set forth in Paragraph A above.

C. No less restrictive measures are available to protect the interests set forth in Paragraph A above.

The Court does therefore

ORDER, ADJUDGE and DECREE that:

1. The Clerk of the Court is hereby directed to seal the file and otherwise prevent the dissemination to the public of the information in the Final Judgment, entered herein on October 12, 2018, and the Amended Final Judgment, entered herein on October 30, 2018.

2. Except for those persons named in any subsequent order and under the conditions set forth in any such order, the following are the only persons to have access to and allowed inspection of this file:

(a) The parties herein and David M. Merritt, Esquire, and staff of David M. Merritt, Esquire, and Jonathan Zisser, Esquire, and the staff of Jonathan Zisser, Esquire;

(b) The Clerk of the Circuit Court and employees thereof in fulfillment of their duties;


(c) Any person who establishes that disclosure of the information is necessary for government or judicial accountability or has a proper first amendment right to the information.

3. The parties and counsel are admonished that they are ordered, likewise, not to disclose or divulge any such information to any individual other than those set

forth herein.


4. The Clerk of the Court is hereby directed to publish this order in accordance with Rule of Judicial Administration 2.420(d)(4).
