**ORDER GRANTING MOTION TO SEAL RESPONDENT'S APPENDIX**

**THIS CAUSE** came before the Court May 27, 2020, on Respondent's, State of Florida, Department of Highway Safety and Motor Vehicles, Motion to Seal Respondent's Appendix, and having considered the pleadings and being otherwise fully advised, it is **ORDERED AND ADJUDGED:**

1. Respondent's Motion to Seal Respondent's Appendix is hereby **GRANTED**.
2. The case at issue involves a petition for writ of certiorari seeking invalidation of a driver license suspension following Petitioner's removal from a DUI Program.
3. Based on the Respondent's motion, the records filed by the Respondent are confidential and exempt from disclosure under Florida and federal law pursuant to Rule 2.420(c)(7), Fla. R. Jud. Admin.

4. The Petitioner's name is not confidential, and no pseudonym needs to be used in this matter. Furthermore, no docket entry to date contains confidential information.

5. In sealing the Respondent's Appendix, the court finds that the degree, duration, and manner of confidentiality ordered by the court are no broader than necessary to protect the interests set forth in Rule 2.420(c), Fla. R. Jud. Admin. No less restrictive measures are available to protect the interests set forth in subdivision (c).
